Executive Summary

March has proved to be a positive month and there has been significant progress on a number of fronts. Internally the boarding operation has progressed swiftly and approximately 50% of the upper floors are now boarded on both sides. In conjunction with this, the first fix electrical has progressed with approximately 80% of apartments being completed. First fix plumbing has been completed to approximately 40% of the apartments. Works to the

metal frame ceilings have just commenced in co-ordination with the ventilation and extract to each apartment.

Externally the facing brickwork is now being progressed to all elevations. The cladding material has now been delivered to the supplier in preparation for final manufacturing. Windows for two floors were delivered to site on Tuesday 28th and these will now be fitted in conjunction with the progression of the external brickwork.

The lift installation has been put back a number of weeks due to progression of existing site activities. This will not affect the critical path however.

Kitchen layouts and specification have now been submitted to LWL for approval.

Overall progress remains consistent at between 16-18 weeks behind the original intent, with a completion date of 02nd June 2017, currently forecast.

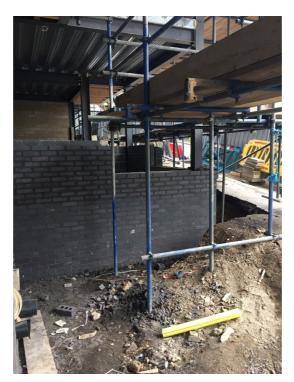

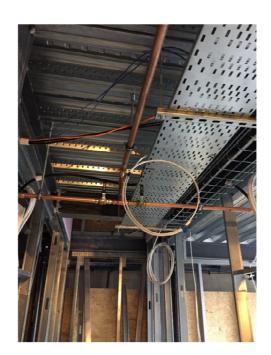

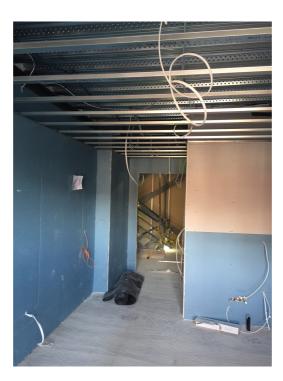
